

**WAIVER AND RELEASE OF LIABILITY AND INDEMNITY AGREEMENT**

**IN CONSIDERATION** of being permitted to participate in a camp and to enter and engage and participate in hockey skills, events on the ice of the hockey facility, the undersigned, for himself and his personal representatives, assigns heirs, and next of kin, agrees, and on the direct representation that he has or will inspect the designated area of the field and the facilities, and that it is safe and reasonably suited for the intended purposes for which the Waiver and Release applies, and now therefore the undersigned.

1. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE , the Central Hockey League, S2S, Dan Wildfong, Joe Ori of which said team is a member or affiliate, their officials, owners, coaches, or instructors, used to conduct this camp event, and each of them, their officers and employees, hereinafter referred to as RELEASES, from all liability to the undersigned, whether caused by negligence of releases or otherwise, while the undersigned is in or on the lacrosse field or facilities, and competing, observing, working for or in any way participating in the camp; and,
2. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS, AND COVENANTS NOT TO SUE the releases of any loss, liability, damage, or cost they incur due to the presence of undersigned in or upon the lacrosse field or facilities, or in any way competing, observing, working, or for any purpose participating in the camp, and whether caused by negligence of the releases or otherwise; and
3. THE UNDERSIGNED expressly acknowledges and agrees the activities of the camp are very dangerous and involve the risk of serious injury and/or death and/or property damage. The undersigned further expressly agrees that the foregoing release, waiver and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the province or state in which this camp event is conducted and that is any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THIS WAIVER AND RELEASE OF LIABILITY AGREEMENT, and further agrees that no oral representation, statements of inducements apart from this foregoing written agreement have been made.
